

Kentucky Resident Drug Overdose Deaths during the Period January 1, 2011 – June 30, 2015

Data are preliminary and subject to change!

There were 1,069 Kentucky resident drug overdose deaths in 2014 according to the death certificates submitted to the Kentucky Office of Vital Statistics. These deaths represented overdoses by illicit and/or prescription drugs that were inflicted intentionally or unintentionally. Most of the deaths involved more than one drug. The total number of drug overdose deaths increased approximately 7% from 2013 to 2014. However, the deaths from historically abused prescription drugs declined from 2011 to 2014 (e.g., oxycodone – 48% decline, oxymorphone – 64%, hydrocodone – 21%, and alprazolam – 39% (see page 2 of the following special emphasis report, http://www.mc.uky.edu/kiprc/programs/KVIPP/drug overdose deaths 00-14.pdf). These declining trends suggest that Kentucky's prescription drug abuse prevention laws passed in House Bill 1 from the 2012 Special Session and the subsequent licensing board regulations contributed to better prescribing practices and decreased diversion of prescribed opioids. Deaths resulting from other drugs (e.g., heroin and fentanyl), however, increased during the reporting period. Fentanyl is a pharmaceutical opioid. However, there is evidence suggesting that in the majority of the fentanyl overdose deaths the fentanyl was illicitly obtained and not diverted from prescribing. According to a CDC health advisory from Oct 26, 2015, Kentucky had the 6th highest number of fentanyl seizures in the U.S. in 2014. (http://emergency.cdc.gov/han/han00384.asp).
